- Summer financial aid cannot disburse until all spring grades are posted and Satisfactory Academic Progress is reviewed.
- Minimum Federal Direct Loan Enrollment Requirements: Undergraduate: 6 credits. Graduate: 4 credits or full-time dissertation guidance.
 - If you drop below the required number of credits for the summer, aid will be canceled and/or a balance may be due to the University.
- <u>Catholic University Undergraduate scholarships and grants are not available during the summer term.</u> Federal grants and loans may be available if eligibility remains for the 2023-2024 academic year. Graduate scholarships and grants are subject to the policies of the respective academic department.
- Loans will disburse to your student account no sooner than 10 business days prior to the start of your first summer session.
- A valid FAFSA (Free Application for Federal Student Aid) for 2023-2024 is required to be on file to receive federal aid. Due to the short length of the summer sessions, the FAFSA should be filled out at studentaid.gov before summer starts. Our office must receive your FAFSA results at least 3 weeks before your last class.

• Financial Aid cannot be processed once your summer classes have ended.
